DAY 1 | Springfield Bound & Route 66 Legends Your Route 66 adventure begins with a photo op at the towering Lauterbach Muffler Man, followed by a delicious lunch at the famous Cozy Dog Drive-In, home of the original corn dog on a stick. Explore the moving and interactive exhibits at the Abraham Lincoln Presidential Library & Museum, then glow beneath vintage neon at the Ace Sign Museum. End your day with dinner and nostalgia at Route 66 Motorheads Bar & Grill—a museum-style eatery packed with memorabilia that celebrates the legend of the road. Overnight: President Abraham Lincoln Springfield, Springfield, IL (L, D)

DAY 2 | Route 66 Heritage & Heartland Charm Fuel up with breakfast before visiting Mahan's Filling Station, a perfectly preserved gas station from the early days of travel. Next, wander through the interactive Illinois State Fairgrounds Route 66 Experience, featuring neon signs, roadside tributes, and retro magic. Then it's on to Chatham, where a preserved brick section of Route 66 awaits your camera. The day wraps up with a light dinner and a relaxing overnight in St. Louis, where you'll be welcomed with a special Route 66 STL Track Pack gift! DAY 3 | Rolling into Springfield, MO

DAY 5 | History & Hospitality in Joplin & Springfield Enjoy a private guided tour of Joplin, featuring local landmarks like the Bonnie & Clyde hideout and Route 66 Mural Park. After a comfort-food lunch at Granny Shaffer's, step back in time at Gary's Gay Parita, a lovingly recreated 1930s Sinclair station. DAY 7 | Bridges, Bottles & Backroads Your final day kicks off with a visit to the historic Chain of Rocks Bridge, one of Route 66's most iconic crossings.
